As discussed at the last Council meeting there is still a need to reclaim the Trust office at Stanhope Station following its use during the Polar Express event. Graham Isom and Bill Warriner are to be approached to clarify the situation.

The Polar express event was used to raise awareness of the Trust and its activities. The Trust display boards were erected in the marquee adjacent to the food outlet in the Stanhope Station car park. Additionally, approximately 6000 No40 Appeal leaflets were distributed with the Polar Express tickets and leaflets advertising the Trust Shop were distributed to passengers on arrival at the station. Both activities were aimed at fund raising.

10 Heritage Services 2014

A wholly owned subsidiary of the Weardale Railway Trust has been registered under the name of Weardale Railway Heritage Services Ltd. The aim of this company is to operate Heritage Rail services on the Weardale Railway and to gift any profits to the Trust. A meeting was held on the 16th January where Phil Charlton agreed

to fulfil the Technical/Operation manager role. In the short term Kevin Richardson and Tony Slack would cover the commercial and start up business plans.

The meeting decided to progress the possibility of using Mike Wood's 122 Railcar which is currently on the Ecclesbourne Railway in Derbyshire. It was thought prudent to undertake a Fitness to Run examination prior to any decision being taken to incur the cost of transporting the unit from its current location to the Weardale Railway.

A volunteer for the Marketing activities of the heritage Services Company is still required. In the meantime the possibility of producing a promotional leaflet, for inclusion on the Bishop Line CRP display table at the A4 Great Goodbye event at Locomotion, is to be investigated with John Askwith.

Operation of a rail service must be covered by a Safety Management System (SMS). Negotiations with the CIC will include the possibility of using the existing SMS. Alternatively, it was suggested that Neal Clarke be contacted to investigate the possibility of producing a SMS independently. The HRA website was to be investigated for a possible pro forma.

A request has been received from BARS for a Trust representative to attend the Safety Standards Rail Group (SSRG). The next meeting is to be held at the Dartmoor Railway.

12 Restoration Activities

12a Carriage and Wagon

There have been no further inspections of the condition of the Mk 1 coach "Nina" since the last meeting. There has been no interest in the possibility of hiring Nina out to another organisation. The possibility of moving Nina to Stanhope Station to provide additional accommodation for the café was discussed.

12b Infrastructure

During the redecoration of Stanhope Station, prior to the Polar Express, a number of areas were identified where remedial work to the structure is required. As the building belongs to Durham County Council they should be approached to undertake the work.

The Station lease is up for renewal next year and negotiations should be started as soon as possible. Action: Peter Baker

Agreement has been reached that the Trust can reclaim the office space used for the Polar Express and that the Trust can establish an Education Room in the Waiting Room on the Down platform (Platform 2).

The availability of furniture stored at Wolsingham Station is to be investigated as is the reclaiming of the two draw filing cabinet in the Ticket Office.
