2. Election of Officers of the Trust

Council agreed to invite Norman to subsequent council meetings as an observer to determine if he wishes to be co-opted.

Council also confirmed unanimously Richard Maughan as custodian of the Trust's steam locomotive No40.

8 Chairman's Report

The Chairman gave a verbal report.

The AGM was very good and had gone very well with no issues raised.

We are now well into the Polar Express event, passenger bookings have already exceeded last year's numbers, and many demands are being placed on our operational volunteers. Thanks to all concerned.

Even though we are in the closed season, as far as our own passenger operations are concerned, there is still much to be done in preparation for 2017. The new timetable leaflets are in the final stage of design and we hope to have them ready for distribution soon. Once the timetable is finalised, we will book the necessary paths on the railway to allow us to keep to our publicised times.

The Sunday Gang volunteers are still working as weather allows – the lines of sight along the trackside are vastly improved.

With recent progress on the redesign of the web site, as well as plans for taking our Trust display to various events, I am optimistic that 2017 will see us make significant progress in publicising the Weardale Railway, and the Trust's part in keeping it viable. Hopefully we will see increasing membership and volunteer numbers as a direct result. Many thanks again to Paul Wilson for successfully bidding for a grant for new display boards, and to those who have volunteered to help, both with maintaining the web-site and with manning the display.

Finally, I have received a proposal to change the Trust financial year end, and correspondingly to move the AGM to early spring. This will avoid a clash, both with the end of our operating season, (especially the Halloween event), and also the run-up to Polar Express. We will consult with our accountants and also discuss at the Trust Council, prior to making a decision.

It was suggested that following the success of the use of Makaton sign language by the staff on the Polar Express, consideration should be given to training the Trust front of house personnel.

12 No 40 Report

The latest report from McEwens detailed the situation as of the 11th November 2016. Council resolved that the boiler smith should be visited in the New Year to review progress.

13 **Projects/Restoration Activities**

A Grant recognition plaque is required to show the CDCF Grant contribution to the restoration of Stanhope Station Canopy. It was agreed that the most appropriate place for such a plaque to be mounted would be the Booking Hall at Stanhope Station. A plaque design is to be developed and brought to Council for approval. Action: Paul Wilson. The contractor that undertook the work on Stanhope Station Canopy has requested a statement/testimony from the Trust to use in his promotional materials. Council agreed to produce this. Action: Tony Slack

There has been no progress on the refurbishment of Wolsingham Station Cabin.

Broadwood Crossing Cabin

- The electricity supply to the cabin has been disconnected at the request of Shenstone.
- A temporary generator supply has been installed for the duration of the Polar Express event.
- An application has been submitted for a new supply.

14 Projects

G5 BG Coach purchase. As part of due diligence an assessment of the current physical state and Fitness to Run is to be undertaken. Action: Peter Baker to arrange.

The possibility of installing a Halt to serve the Kingfisher Caravan Park was discussed. Early discussions with the Caravan Park owners have been very encouraging and there is a possibility that costs may be shared. A design would be required to be drawn up and planning permission sought before a properly costed project could be drawn up.

15 Trust Promotion drive

Progress on the updating of the website is to be an agenda item for monthly tracking by Council.

Yesterday Belongs to You event at Beamish in 2017. This is a major Regional event that the Trust usually attends. John Askwith will lead again this year with appropriate assistance. A copy of the Company Public Liability insurance is required as part of the Registration process.

As stated previously 2017 will see all trains operating between Stanhope and Witton-le-Wear on timetabled operating days.

It is the intention to distribute Customer Feedback forms to determine the make-up of passengers and their reasons for travelling on the railway.
