Mark Westerfield Director - BARS/Iowa Pacific

The Chair Kevin Hillary introduced Mark Westerfield BARS/lowa Pacific. Mark gave a verbal presentation on the structure of lowa Pacific and its future business plans for the Weardale Railway. The objectives over the next few months is to re-attach the line to the network at Bishop Auckland, generate freight business, rebuild Witton-le – Wear crossing, repair the landslip and rebuild the trackwork in preparation for freight operations. Mark also confirmed the approval to purchase a wood chipper to help with vegetation clearance. He also confirmed that Dave Million has been appointed joint Trust and WRCIC volunteer co-ordinator. Mike Woods asked about access to the depot and Steve Raine commented access required a JCB, volunteers and some new fencing. The Directors discussed commercially confidential information – no decisions were taken and the Directors expressed their thanks to Mark for his briefing and candour.

6 Financial Officer's report (Peter Shields)

The Financial Officer Peter Shields commented on the financial report previously emailed out. This month's expenditure was mainly for uniforms for the Junior Club (paid for by the Trust) expenditure on Number 40 and part repayment on Number 40 rebuilding loan – this loan should be repaid by the end of the financial year. Income included a £2020 grant for training.

Peter commented that a £1000 refund had been made to Ron Endicott due to a mistake on his donation cheque.

Steve Raine commented that the loan agreement from the Trust to WRCIC and its corresponding legal agreement have yet to be signed. This document needs to be signed by Steve Raine and Graham Lord (on behalf of WRCIC), Kevin Buswith and Ed Ellis (on behalf of BARS), Durham CC to sign, Sherburn Stone to sign and Kevin Hillary and another Trust Director or Company Secretary to sign on behalf of WRT. Steve commented that Wear Valley District Council have donated their loan to WRCIC.

8 Number 40

Gerry Mudd reported on the status of Number 40s rebuild and the expenditure so far. Expenditure to date is £68,000 with £2,500 identified for contingencies and boiler certificate. Income this month was £200 from the Junior Club (total so far of £2000) and total income to date from donations and other sources is £24,000.

The tanks and cab sides have been fitted and the steam pipe has been pressure tested and passed to be fitted. The boiler inspection is set for 8th April and Steve Butler (BARS Steam expert) is to be on site at Weardale depot to look at the rebuild and the UK steam scene. Gerry thanked the volunteers for all their efforts on Number 40. Gerry commented on the procedures such as daily fitness to run which will be modelled on NRM procedures.

Arthur Temple reported that he had tracked down the mechanical drawings for Number 40 and 2 sets had been obtained. Malcolm Simpson commented on the need for the proper paperwork on boiler certificates and annual inspections.

9a Locomotives

It was reported that 37414 has left the railway and Class 73 may be in operation for Mother Day. The Directors discussed the 0-6-0 MacAlpine shunter which needs to be added to the Trust asset register, a suitable donation plaque needs to be provided or the loco named and an operating agreement between the Trust and WRCIC needs to be in place. Gerry agreed to construct an agreement and Steve Raine is to find the paperwork covering this locomotive. The Director agreed to move this item 9a to item 8.
