Gerry Mudd reported that 3 Trust Directors met with Ed Ellis today and presented a report (a copy of this briefing document was handed out to the Trust Directors for their reference) about issues which are concerning the Trust Directors and Trust members over the operation of the railway. After this meeting the 3 Trust Directors met with Iowa Pacific and BARs management to discuss the issues in more detail. The Directors discussed the issues (some were commercially confidential) and no decisions were taken.
