6 Chairman's Report

The Chairman had circulated an email prior to the meeting. The Chairman read out a congratulatory letter from a new member Rob Griffith who enjoyed his visit to the railway and further commented on the friendliness of the volunteers. 7 Treasurer's report

The Treasurer reported on the comments made by the independent examiners Allen Sykes about the Trusts outstanding debts owed by WRCIC for Number 40 hire charges. The Treasurer gave a verbal summary of the financial activity during September. Income - £1000 and expenditure was £5000 of which £4300 was spent on

number 40. Further known expenditure (no invoices yet received) for Number 40 consists of £3000 machining costs (Richard Campbell) and Malcolm Simpson's extra expenses (valves and spring hangers).

8 Secretary's report

No report was presented. The Directors reviewed the final version of the Code of Conduct for Trust Council and approved the document which will be signed by the Directors after the AGM.

AGM - Pie and Peas 3 junior members have been requested to help – Trevor Hewitt to speak to David Million. It was agreed that all the money taken at the AGM will be paid directly to the Treasurer.

Train Trip before/after AGM – a travel voucher for a train trip on the day (to be produced by David Scott) will issued on production of a membership card – this needs to be cleared by the General Manager before being publicised in BTL.

9 Number 40

Malcolm Simpson reported that the work on the bearing is completed and have been fitted awaiting the delivery of 12 spring hangers. Malcolm also reported that 1 spring has been repaired and another spring is to be repaired (which will be the 'spare spring'). Oil and water drains have been fitted at a cost of £23 for parts. Gerry Mudd reported that work should be completed by the end of the week. Base don progress so far Number 40 should be available for steam trails next week and be available for passenger services around 23/24th October. The Number 40 appeal has raised £4000 to date.
