Expenditure was just under £1700 made up of machining for Number 40 bearings £300 BTL printing costs of £590 and draw tickets costs of £168.

9 Number 40

Richard Maughan gave a brief verbal report. The light engine test was successful and a loaded test is scheduled for 15th March. Work on fitting the combined steam and vacuum brake valve will start on 20th March with the assistance of Alan Freebury. The ten year inspection is due on 23rd May and subject to a successful inspection Number 40 may have an extension to its certificate until January 2013. Richard and Trevor commented that a 10 year overhaul work on Number 40 will take 6 – 8 months.

13a/13bReport from the Company Board meetings/ Report from Management Group meetings (Trust representatives)

Steve Raine/Brian Cox and Gerry Mudd reported the following:

- Fares The Directors discussed the proposed (by WRCIC) fare structure for this year which will include a family ticket and the usual reductions for children and seniors. The target is for 20,000 passengers this year based on 2 round trip trains per day. The Directors approved the fare structure.
- Bishop Auckland Station Project The current building is sub leased by WRCIC from Northern Rail and WRCIC would like to alter the building configuration to include a ticket office and toilet facilities. WRCIC have approached the Trust to see if any volunteers could help with interior conversion work such as plumbing etc. WRCIC would supply materials however the Trust needs to check its insurance to see if volunteers are covered to work on Network Rail property.
- Shop no response to the Trust proposals. Any profits the shop generated under the Trusts management WRCIC would require an input on which projects the surplus money is spent. The Directors discussed the issues. Gerry agreed to work up a proposal.
- Junior Club coach needs a risk assessment.
- CCTV This is needed in the depot. WRCIC have asked if the Trust has a volunteer who has experience in this field. Steve Raine agreed to check out with his contacts.
- Brake vans/coaches Mike Woods Mk 1 brake coach will not be available. Mike Wood is to email Graham Isom detailing the work needed to allow the LMS brake coach to couple up to the Trusts Mk 1 coaches.
- First aid training The Trust has money available for training volunteers. Carroll to speak to Arthur Temple about training contacts.
- Wilf Hulme 100th Birthday Our Vice President is 100 on September 17th and his family is organising an event on 16th September. The Directors discussed arrangements which the Trust could undertake on the 16th September to celebrate this event.
- Steve Raine expressed his wish to retire from the board of WRCIC due to family business commitments. The Directors thanked Steve for all his efforts as a Trust Director and his work on behalf of the project.
