5 Chairman's Report

The Chairman (Ian Gardner) was unable to attend due to prior commitments and had previously emailed his report. As the Chairman has announced his intention to stand down at the AGM the Vice Chair thanked Ian for all his hard work on behalf of the Trust.

6 Treasurer's report

Trevor commented on his report he had previously emailed out. This month's income was £15,000 consisting of £9,000 loan from a member to help cash flow work on Number 40 and £6,000 VAT reclaim. Expenditure was £600.

7 Secretary's report

No report was presented.

Changes to Weardale Railways CIC M&As, changes to the membership of Weardale Railways CIC, changes to the Directorships of Weardale Railways CIC – The Secretary reviewed the changes to the structures of Weardale Railways CIC and recommended that the Trust Council retrospectively agree to these changes (these changes had already been approved by the board of Weardale Railways CIC on which the Trust has 3 directorships.).

The Directors approved the changes to Weardale Railways CIC strucutures.

AGM – The Directors agreed that the AGM will start at 10:00 AM however the special train will not run to Harperley due to concerns expressed by the HMRI – our operating licence covers trains operating from Stanhope to Wolsingham.

Election of Directors – The Secretary reminded the Directors that retiring Directors subject to the rotation of Trust Council members (Clause 56) should be nominated using the appropriate forms from 16th September until 4th October 2008.

8 Number 40

Trevor reported that the firebox and boiler will be delivered to Wolsingham on 15th September. David Wright will be called in to provide expert advice and a to-do list on rebuilding Number 40. It was agreed that the volunteers working on Number 40 will provide technical competencies or CVs.

Trevor commented that there is a shortfall of £20,000 to cover the rebuilding costs of Number 40 - some Trust owned items such as point motors are still to be sold. A formalised loan agreement has been drawn up covering a repayment period of 1 year with a maximum loan period of 2 years. The appeal has so far raised £18,000 with the Junior Club raising £2,000. The Directors thanked John Lewin who provided the photo-montages for donors to the Number 40 appeal fund.

Weardale Railways CIC Reports

9a Report from the Trusts sub committee (Trust representatives)

No report – this item is to be dropped from the agenda.

9b/9c Report from the Company Board meetings/ Report from Management Group meetings (Trust representatives)

New company accounts covering Dartmoor/RMS Locotec/WRCIC have been produced for review by the Directors and monthly accounts for WRCIC have been produced from April 2008. Accounts for July show a deficit of £10,000 and this shows the need to make £1,000 every operating day with capital costs to be kept to a minimum. An accountant (John Toulson) has been appointed and is working on getting creditors paid. Michael Fairburn (Locotech) is to take over from Bill Donaldson as Group General Manager and BARS (Iowa Pacific UK subsidiary) will appoint 3 Directors to replace the current ECT nominated directors. It was noted that WVDC have still to apply to be a member of WRCIC. Steve Raine reported that the 'annual community interest report' still needs to be completed and sent to the CIC regulator.

Graham Lord reported that the departmental heads have been requested to provide reports one week before the the WRCIC Directors meetings. The next WRCIC board meeting will take place on 7th October at County Hall starting at 9:30am.

Timetable 2009 – Graham Lord/Marketing/Ops Groups are to decide on the timetable for 2009.

Steve also reported that Wolsingham Steel is planning to sue WRCIC for £100k. The company lawyers are reviewing the issues.

3809 – This engine is to be sold and the money used to purchase another running steam engine.

A plan to run special trains in the evenings requires additional lighting and is not currently considered feasible.

Credit Card – WRCIC board has accepted the offer from the Trust to provide a credit card facility which will be processed through the Trusts bank account and a phone line has been installed for electronic processing. Money will be transferred to WRCIC by BACs or cheque with a report sent to WRCIC's accountant.

9d Report from the Marketing Group meeting (John Askwith)

John Askwith reported that the Marketing Team has been working on a draft timetable for 2009. No trains will be run in February and November as requested by the Operations/Infrastructure teams.

Publicity – leaflets covering Rolls Royce Day and Santa Specials have been distributed with the assistance of WVDC.

Brown Signs - Brian Cox asked about these signs as two appear to be missing. Steve Raine is to liaise with DCC.

Toilet block at Wolsingham – Gerry reported that the design was complete with the project costing approx $\pounds40,000$ if mains sewerage is available. If a septic tank is required this would cost an additional $\pounds12,000$. Funding for this project will probably come from multiple funders.

Weardale Community Partnership – Steve Raine reported that there would be a transport meeting on 11th September at the Weardale Hub and asked if a volunteer could attend and report back. Any volunteer was asked to contact Steve Raine.

Steve reported that Ed Ellis had met with the Friends of Dartmoor Railway and is keen to help set up a similar organisation to the Weardale Railway Trust. Mike Woods/Dave Foxton and Kevin Hillary agreed to offer advice on general volunteering issues, Gerry Mudd agreed to advise on finance and James Lynn agreed to advise on legal structures and charitable status.

Renewal of Stanhope Station lease – Gerry reported that Cathy Priest from WVDC had offered a 6 year lease but Gerry will work on getting a 10 year lease.

Eastgate Task Force – Planning consent meeting now set for mid January 2009 due to an intervention from Natural England.

John Askwith reported that a major incident training exercise was undertaken last night by the emergency services. 2 complaints had been received about the lack of information that this exercise was going to take place.

Graham Lord asked about the ownership of assets stored in the depot. Dave Foxton is to respond about Loco Group assets however the Directors were uncertain if any ECT assets were still stored in the depot.

Brain Cox reported that BBC Northeast had been filming on the railway for a report on the effect of Dr Beeching closures on branch lines in the Northeast.
